1. Called to order by Chair, Mark Tkacz at 7:02PM
2. Report on Quorum: Eight (8) votes present at scheduled meeting start time of 7:00PM; fifteen (15) required to proceed. Meeting adjourned at 7:05 and called to order at 7:20PM as per bylaw 24.1 – Inability to meet quorum. Eleven (11) votes present upon reconvening.
3. Reading of the Notice of Meeting. Notice was emailed to members and posted as News on club website.
4. **MOTION:** To approve the agenda. Moved by Carol Manson McLeod; seconded by Mark Tkacz. CARRIED
5. **MOTION:** To approve minutes of 2022-23 season Annual General Meeting. Moved Caitlin McLeod; seconded by Val Laferriere. CARRIED
6. Confirmation of actions taken by the Board. No specific actions of note.

MOTION: that the actions of the Board of Directors of the Society, and/or persons duly designated by the Board of Directors of the Society in the conduct of its business since the annual general meeting of the members, be duly ratified, adopted, confirmed and approved as act and deed of the Society. 7. Secretary's report
 - Board met consistently with 4 to 6 weeks between meetings. (8 virtual meetings convened from June 2023 through April 2024). No motions were passed at meetings without quorum. Issues were discussed as they arose between meetings via email. Minutes are available for members upon request.
 - Administrative motion of note is that decisions presented to Board via email are considered passed after 3 days unless 4 dissenting votes are received.
8. Treasurer's report
 - Current financial health of Club is good.
 - August 2023 casino monies received in 2023Q3 - \$61,925. Cash flow strategy is to use up casino money and earn interest on registration fees in our savings account as current interest rates make this worthwhile.
 - 2022-23 statements shared on screen
 - i. Total assets of \$138,903
 - ii. Total liabilities – \$30,635. Mostly deferred revenue consisting of prepaid skating fees and grant money not yet used for the intended purpose.
 - iii. Total revenue – \$122,093 consists of registrations, remaining casino funds and Return to Play grant.

- iv. Total expenses – \$111,012 consists of facility rental and program expenses, coaching fees and casino expenses.
- v. Profit on the year of \$11,000 can mostly be attributed to Return to Play grant (\$13,000).
- Ice Show 2024 looks to be essentially breakeven. Significant profit is not a primary goal of the event.

MOTION: To approve the 2022-23 Financial Statements as posted on Club website prior to meeting. Audited by John Jacques and Noriko Ohsada. Moved by: Mark Tkacz; seconded by Dominique Schmaltz. CARRIED.
